PRESIDENT'S CORNER

Three of the most important functions of our board are dues collection, road maintenance, and adhering to our covenants. This year we have collected over 98 percent of dues owed, and liens have been filed against those who still have not paid. By the end of the summer we will have repaved almost one mile of our private roads that were not only unsafe but were also eroding our property values. Our ACC has a most important and largely thankless job of enforcing and in some cases interpreting our covenants. All in all our area looks great, new flags are flying, and our finances are in good shape.

BOARD OF DIRECTORS

At our annual membership meeting in January Scott Kehoe and Steve Cokor were elected to three-year terms on the Board of Directors. Susanne Oppegaard was elected to a three-year term on the Architectural Control Committee.

We appreciate the support of our Olde Point residents who live outside of the covenant-mandated boundaries of OPPOA, and their financial support helps pay for our community-wide programs and activities.

COMMUNITY RELATIONS

Earlier this year OPPOA provided a written survey to its members concerning the suggestion of turning the vacant land at the intersection of Olde Point Road and Olde Point Loop into a playground facility. Thank you to everyone who took time to vote and share their thoughts regarding a community playground. We had an overwhelming response with the majority of those voting against having a playground. Only a few members expressed utilizing the property for a different use such as a dog walk or walking path. At this time the Board has chosen not to do anything with the property.

ROADS

At its May 2015 Board of Directors meeting the board approved the expenditure of up to \$34,600.00 for the repaving of the portion of Shearwater Drive that intersects both ends of Oystercatcher Drive, and additional repairs to potholes on Osprey and Oystercatcher where necessary. A contractor has been hired, but a firm starting date for the work has not yet been provided.

ARCHITECTURAL CONTROL COMMITTEE

During the past four months ACC members have met on numerous occasions to consider a possible change in its policy concerning the approval of fences. At its June 1, 2015 meeting the committee members voted to approve the following resolution:

WHEREAS, Section 7(d) of the Restrictive Covenants of the Olde Point Property Owners Association(OPPOA), states that "No fence shall be located on any lot except as have been approved by the Architectural Control Committee. Fences are generally discouraged except for special circumstances such as safety around pools...".

AND WHERE AS, the Restrictive Covenants further state that "Restricted approvals of fences are subject to the following strict requirements and conditions: 1. Chain-link, wire or chicken wire fences are prohibited. 2. All location, design and construction and materials must be approved in writing in advance by the Architectural Control Committee. 3. The fence shall be no closer than three(3) feet to adjacent property lines and no closer that fifty(50) feet to golf course boundaries subject to exception granted by the Architectural Control Committee; 4. Four(4) foot minimum height fences are mandatory for pool enclosures as required by State and Pender County ordinances.

THEREFORE, after careful and deliberate consideration by the ACC, the following policy has been formulated and approved by the members of the ACC for restricted consideration for approval of fence requests from its membership in addition to the above restrictions set forth in the covenants.

- 1. No wood privacy fence requests or front yard fence requests will be approved. All fences considered for approval must be of wrought iron, aluminum or vinyl and have at least three inches of space between vertical pickets or rails, and be of a height not exceeding four(4) feet, with the exception of fences around pools, which cannot exceed five(5) feet.
- 2. The ACC may require a written acknowledgement of approval of the fence by adjacent property owners.
- 3. The ACC may restrict the location, size and shape of any fence being requested based on any ground that in the sole discretion of the ACC shall seem sufficient.

It is further acknowledged that this policy may be altered, changed, or discontinued by any subsequent Architectural Control Committee by a vote of its members, and that such changes to this policy should be made in writing and published to the membership.
